A. Information You Provide Directly

We do **not** store full payment information on our servers.

B. Automatically Collected Information (via Wix)

Wix automatically collects:

- IP address
- Device type
- Browser type
- Operating system
- Pages viewed
- Session duration
- Referring website
- General location (city/region)

This helps us improve site performance and user experience.

C. Cookies & Tracking Technologies

Wix uses cookies for:

- Site security
- Analytics
- Functionality (e.g., remembering your preferences)
- Marketing or advertising (if enabled)

You can manage cookies through your browser settings.

3. How We Use Your Information

We use your information to:

- Respond to inquiries
- Provide voice lessons and studio services
- Process payments
- Communicate scheduling or studio updates
- Send newsletters or promotional emails (optional)
- Improve website performance
- Maintain studio records
- Comply with legal requirements

We do **not** sell your personal information.
