

Terms and Conditions

Effective Date: June 20, 2026

These Terms and Conditions ("Terms") govern your use of www.full-body Singing Studio.com and any related services, content, lesson booking features, digital materials, and online voice instruction offered through **Full-Body Singing Studio** ("Studio," "we," "us," or "our").

By accessing this website, booking lessons, purchasing services, downloading materials, or otherwise using the site, you agree to these Terms. If you do not agree, do not use the site or services.

1. Use of This Website

You may use this website only for lawful purposes and in accordance with these Terms.

You agree not to:

- use the site in any way that violates applicable law;
- interfere with the site's operation or security;
- copy, distribute, scrape, reproduce, or commercially exploit site content without written permission;
- submit false or misleading information through forms, bookings, or inquiries;
- impersonate another person or misrepresent your identity.

We reserve the right to suspend or restrict access to the site if these Terms are violated.

If lessons are purchased for a student under 18, a parent or legal guardian must agree to these Terms and is financially responsible for all fees, charges, and compliance with studio policies on behalf of the minor.

We may require parental or guardian consent before providing services to minors.

4. Scheduling, Booking, and Lesson Access

Lessons, consultations, classes, or other services must be scheduled through our approved booking process.

You are responsible for:

- providing accurate contact and billing information;
- attending lessons on time;
- ensuring access to a stable internet connection, a functioning device, and any required software or platform;
- using a quiet and safe environment appropriate for online instruction.

Late arrival by a student does not extend the scheduled lesson time unless we choose otherwise at our discretion.

5. Payment Terms

Fees for lessons, packages, classes, memberships, or digital offerings are listed on the website or otherwise communicated before purchase.

By purchasing services, you agree to pay all applicable fees, taxes, and charges.

Unless otherwise stated:

- payment is due in advance of the lesson or service;
- purchased lesson packages are non-transferable;
- unpaid balances may result in suspension of bookings or services;
- we reserve the right to change pricing prospectively by posting updated pricing on the site or notifying clients in advance.

If a payment is disputed, reversed, or charged back improperly, we may suspend future services until the matter is resolved.

6. Cancellation, Rescheduling, and Refund Policy

Students must provide at least **48 hours' notice** to cancel or reschedule a private lesson. Lessons canceled with less than 48 hours' notice may be forfeited and are not eligible for refund or makeup credit.

Missed lessons or no-shows are treated as completed sessions and are not refundable.

If the Studio must cancel a lesson, we will make reasonable efforts to reschedule it or provide an appropriate credit or refund.

Refunds for lesson packages, memberships, or prepaid services, if any, are governed solely by the refund policy stated at the time of purchase.

Online lessons depend on third-party platforms, devices, software, audio equipment, and internet connectivity that are outside our control.

We are not responsible for interruptions, delays, degraded sound quality, platform outages, or other technology issues caused by:
